SYLLABUS

Comparative Conflict of Laws

16 hours (8 classes of 2 hours each)

Description of the course

The course provides an introduction to the conflict of laws (or, in other terms, "private international law") in a comparative perspective. It focuses on four major legal systems (England and Wales, the U.S., France and the European Union), with particular emphasis on one key issue raised by private law situations having a foreign element: the international jurisdiction of courts.

Objectives

This Module aims to help the student:

- Understand the legal problems raised by private law disputes involving individuals and companies from different countries;
- Become familiar with the principles that help solve these problems in common law and in civil law systems;
- Analyze and assess critically court decisions in this field of the law.

Development of Skills Base

A successful candidate on this Module should:

- Possess a firm knowledge and understanding of Private International Law;
- Be able to evaluate critically new developments in this area;
- Be capable of utilising a full range of learning and research resources.
